National planning policy requires us to plan to meet expected development needs.

Our current Local Plan was adopted in 2015 and we are working on a review to ensure it remains up to date. The Local Plan Review will shape how the area develops over the next 15 years – and we want your thoughts.

Our plan does not cover areas of Chichester District that fall within the South Downs National Park, which produces its own plan.

We live and work in an incredibly special place and we want to keep it that way. Reviewing the Local Plan will help us to protect the area, while also addressing the area's needs.

The Local Plan will help to:

- choose where development goes;
- protect the character and beauty of the area;
- provide job and housing opportunities so that our children can continue to work and live locally;
- support and help to boost the local economy;
- help our residents to maintain healthy and active lifestyles; and,
- make sure that we have adequate services, travel options and community facilities.

We realise that there is a shortage of suitable homes; well-paid local jobs; and important facilities and services. This is our chance to work with you to make sure that our area has a bright future, with a strong economy, and a thriving working age population.

Without an up to date Local Plan we will not be able to access vital funds to support our communities. By controlling new developments we have the opportunity to focus development in the most appropriate locations.
