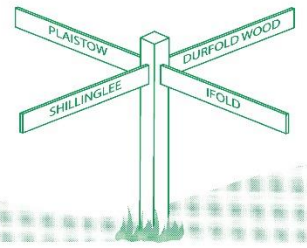


PLAISTOW AND IFOLD PARISH COUNCIL

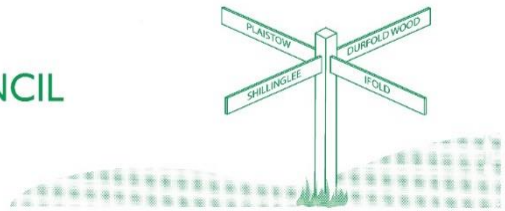

Re: 15/00804/FUL. To site a mobile home (temporary) at Weald Barkfold Farm.

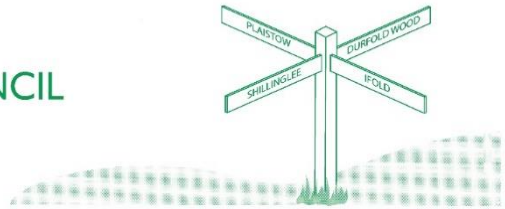
