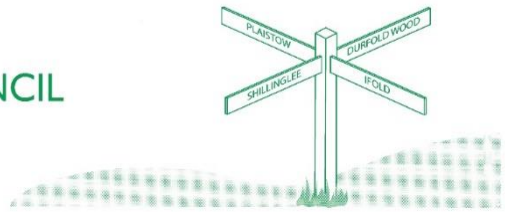

Re: 15/02359/FUL Replacement dwelling. Thane, The Drive, Ifold.

Plaistow and Ifold Parish Council would have no objection in principle to a replacement dwelling on this site and comments that the proposals are a significant improvement on previous applications.

However, the parish council considers that due to the 9m ridge height and large projecting two storey double garage, the proposed building would be overbearing on the street scene due to its bulk and mass. The building is also set further back into the site compared with the neighbouring properties and this would impact on the amenity of rear gardens and particularly 'Lanterns'. There appears to be no grounds to justify this position and the parish council sees no reason why the building could not be brought forward and the garage block shortened. For these reasons, the parish council **OBJECTS** to this application as it stands.
